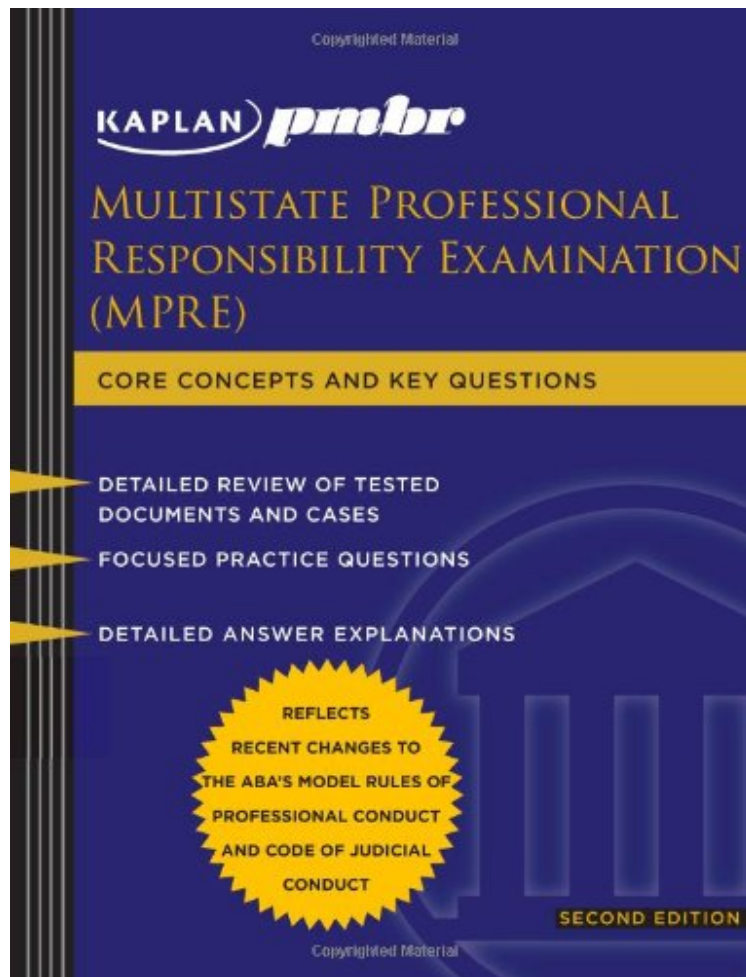

The outline in the beginning is very short and provides misleading information about the model rules. The sample test questions test on things that are not included in the MPRE and test in a format that is not included on the MPRE. Some of the answers are just plain WRONG!! It does not come close to covering all the requisite law and the questions are FAR easier and FAR shorter than those on the actual exam. This is perhaps useful as a supplement to Barbri review since it is brief and simple. But don't rely on it alone.
