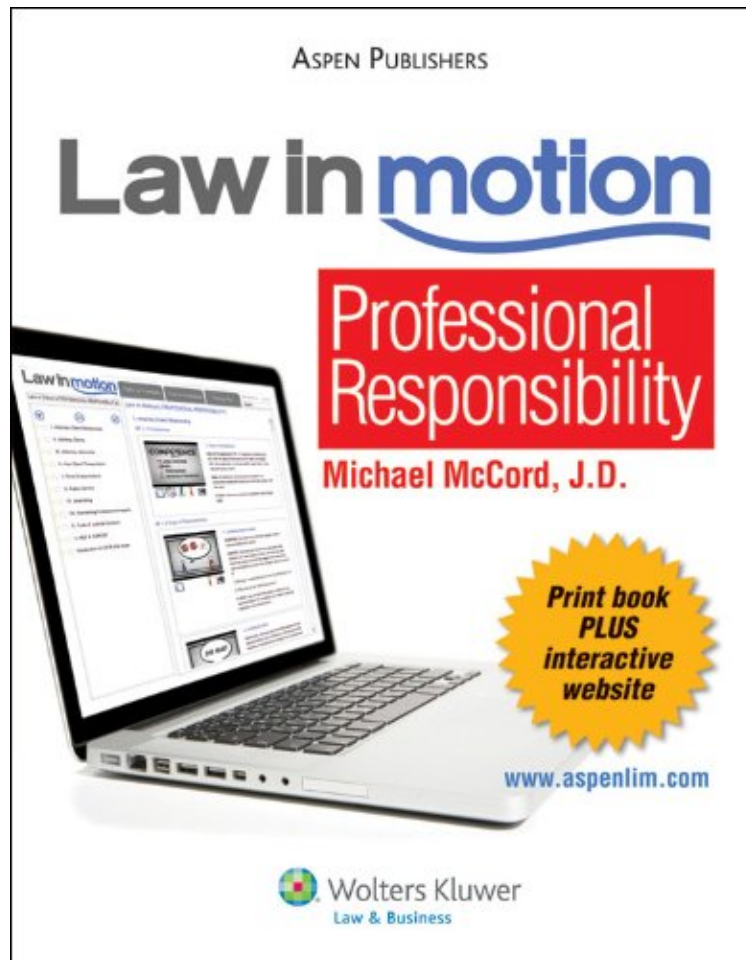

This book did not prepare me at all for the format of the questions on the MPRE and I would only suggest this text to someone currently in a professional responsibility or legal ethics course because otherwise it is a review that seriously lacks in substance and value. Moreover, several questions available through the website online were not linked with their correct answers, making a true interactive review without pen and paper and step by step review of each answer to each question impossible. The software could not be trusted to calculate the correct or incorrect percentage in a group of questions. Parts of the website program did not work properly- specifically the audible/video review was not completely operational. Wish I had not wasted my time or money with this product and will certainly
